

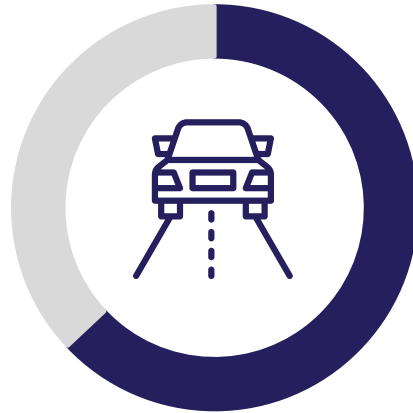
Road safety in Victorian primary schools

This infographic presents key findings from the Road Safety Education Victoria (RSEV) primary school baseline survey, one of a series conducted between 2023 to 2025 across Victorian primary, secondary and specialist schools, as well as early childhood settings. The surveys were conducted by Wallis Social Research on behalf of the RSEV partnership – including the Transport Accident Commission, Victoria Police and the Department of Transport and Planning – to help identify opportunities to better support the education sector, both in strengthening road safety education and in improving safety within and beyond the school gate. ROAD SAFETY PRIORITISATION

Prioritising road safety helps students become safe and responsible road users from a young age and improves road safety beyond the school gate. Of the schools surveyed, a high number (63%) consider road safety an 'essential' or 'high' priority.

PROGRAMS AND RESOURCES

Road safety programs are an important component of an evidence-based, whole-of-school approach to road safety education. Most schools surveyed (67%) had participated in a road safety program or used a resource in the past 5 years.

POLICY

Implementing a comprehensive, standalone road safety policy enables schools to adopt a holistic approach to road safety. A modest number of schools surveyed (8%) have a dedicated road safety policy. More schools integrate road safety topics into existing policies.

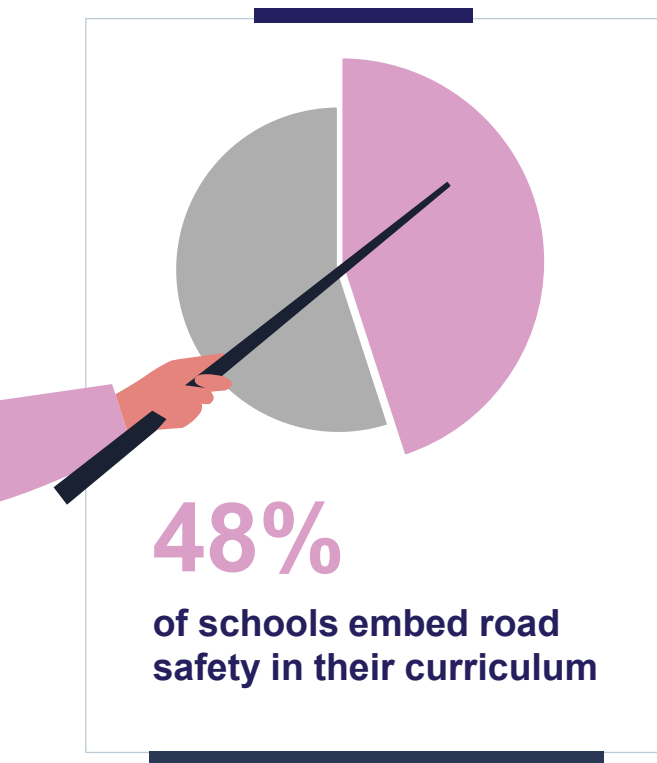

CURRICULUM

Evidence-based road safety curriculum content should be delivered regularly and sequentially throughout a child's school years, matching their development stage and level of independence as a road user. Almost half of the schools surveyed (48%) reported that teachers incorporate road safety into the curriculum.

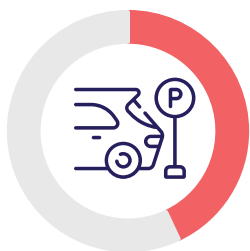


STAKEHOLDER ENGAGEMENT

Engaging the wider school community can strengthen road safety action. A high number of schools surveyed (74%) had sought external support to improve road safety around their school in the last five years. Of those that sought support, schools were most likely to engage with local councils (87%) and their school community (71%).

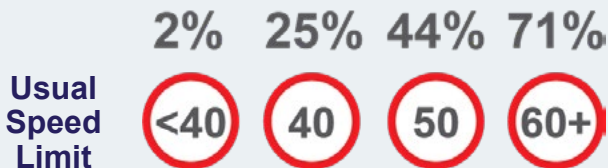
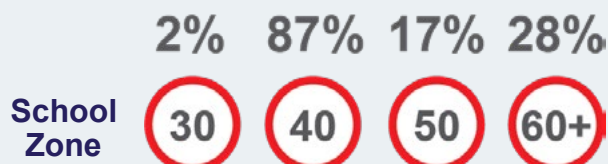

Pedestrian crossings are vital for road safety. Nearly three-quarters of schools surveyed (73%) have a school and/or pedestrian crossing for students to use when crossing the road around the school. Wombat crossings (raised pedestrian crossings) are less common (5%).



Safe speeds are essential for creating safe road environments. Most participating schools (87%) had a 40km/h school zone on at least one surrounding road. Outside school zone hours, the majority of schools (71%) were on roads signed at 60km/h or above.

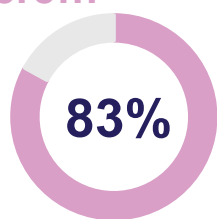


SAFE ACTIVE TRANSPORT

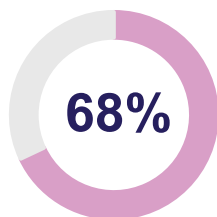
Encouraging safe active transport can improve road safety around the school, increase health and wellbeing and is good for the environment. Nearly three-quarters of participating schools (73%) encourage safe, active forms of travel.

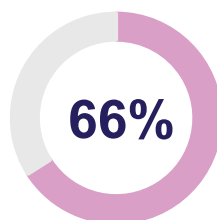
Of the 73% that encourage safe active transport, key activities were...
