

Road Safety in Victorian early childhood services

This summary presents key findings from the Road Safety Education Victoria (RSEV) early childhood services baseline survey, which is part of a series conducted from 2023 to 2025 across Victorian primary, secondary, and specialist schools, as well as early childhood settings. The surveys, carried out by Wallis Social Research on behalf of the RSEV partnership—including the Transport Accident Commission (TAC), Department of Transport and Planning (DTP), Public Transport Victoria (PTV), and Victoria Police (VicPol)—aimed to identify road safety priorities, knowledge, and practices. ROAD SAFETY PRIORITISATION

Prioritising road safety in early childhood service environments supports road safety education and helps to safeguard children and families from road related injury. Of the early childhood settings surveyed, over half (62%) consider road safety an 'essential' or 'high' priority.

PROGRAMS AND RESOURCES

Road safety programs play a crucial role in establishing a solid foundation for safe road use throughout life. Most early childhood settings surveyed (72%) had participated in a road safety program or used a resource in the past 5 years.

CURRICULUM

Evidence-based road safety curriculum content should be delivered regularly and sequentially throughout a child's education, matching their development stage and level of independence as a road user. More than three-quarters of services surveyed (77%) reported that educators incorporate road safety into the curriculum.

POLICY

Implementing a comprehensive, standalone road safety policy enables services to adopt a holistic approach to road safety. More than half of services surveyed (66%) have a dedicated road safety policy. More services integrate road safety topics into existing policies.

STAKEHOLDER ENGAGEMENT

Engaging the wider community can strengthen road safety action. A moderate number of services surveyed (40%) had sought external support to improve road safety around their services in the last five years. Of those that sought support, schools were most likely to engage with local councils (75%) and their service community (50%).

Pedestrian crossings are vital for road safety. More than half of services surveyed (61%) have a school and/or pedestrian crossing for children to use when crossing the road around the service. Wombat crossings (raised pedestrian crossings) are less common (3%).

Limit

Six-in-ten services have 60km/h or higher speed limits adjacent to the services.

Safe speeds are crucial to safe road environments, particularly around services. A speed limit of 60km/h or higher on a road adjacent to the service was found at half of participating services (50%).

SAFE ACTIVE TRANSPORT

Ways services promote safe active transport...



encourage helmet wearing



provide facilities for bicycles or scooters



Encourage families to walk part of the way to the service





Encouraging safe active transport can improve road safety around the service, increase health and wellbeing and is good for the environment. More than half of services surveyed (60%) encourage helmet wearing.
